Quality Assurance (QA) Framework**

Level	Roles and Responsibilities
University	<p><b><u>Senate</u></b> The Senate is the highest authority on all academic related matters of the University.</p> <p><b><u>Senate-Standing Committees</u></b> Formed under the Senate, the Academic Development Committee, Sub-degree Programmes Steering Committee, Quality Assurance Committee, Research Committee, Teaching and Learning Policy Committee and Student Affairs Committee are charged with different spectrum of responsibilities for quality assurance (QA):</p> <p><b><u>Academic Development Committee</u></b> Formulating academic policy and academic strategic and development plans, and examining planning proposals of new programmes.</p> <p><b><u>Sub-degree Programmes Steering Committee</u></b> Overseeing the planning, operations and long-term development of self-financed sub-degree (SD) programmes.</p> <p><b><u>Quality Assurance Committee</u></b> Formulating QA policies and procedures; monitoring and assuring the quality of all taught programmes at SD, undergraduate and taught postgraduate levels, including UGC-funded and self-financed programmes offered within and outside Hong Kong. The QAC's sub-committees, including Taught Postgraduate Regulations Committee, two Quality Assurance Sub-committees on Sub-degree Programmes, General Education Committee, Undergraduate Admissions Committee and Undergraduate Regulations Committee, are formed with respective roles and responsibilities.</p> <p><b><u>Research Committee</u></b> Developing strategies as well as formulating and reviewing policies relating to research postgraduate programmes.</p> <p><b><u>Teaching and Learning Policy Committee</u></b> Enhancing and maintaining general oversight of university-wide policies and procedures relating to teaching and learning such as the assessment policy.</p> <p><b><u>Student Affairs Committee</u></b> Formulating policies and regulations relating to student organisations, activities, discipline, amenities, services and hall life; steering co-curricular and other activities which create an environment conducive to the Whole Person Education philosophy of the University.</p>
Faculty <sup>Notes</sup> 1&2	<p>The Faculty is responsible for:</p> <ol style="list-style-type: none"> <li>(1) Upholding and monitoring the quality of the academic programmes, academic activities and/or support services offered by its departments;</li> <li>(2) Providing guidance on and monitoring implementation of QA at the departmental level;</li> </ol>

	<p>(3) Reviewing various annual reports (e.g., <a href="#">Annual Programme QA Reports</a>) submitted by departments and programmes;</p> <p>(4) Following up on improvement plans, including recommendations made by the Academic Consultation Panel and Departmental Academic Advisor, in previous Reports;</p> <p>(5) Formulating improvement plans with measurable targets and concrete time frame for continuous enhancement.</p>
<p><b>Department</b> Note 2</p>	<p>The Department is responsible for:</p> <p>(1) Upholding the quality of the programmes, courses and other learning activities offered by the Department;</p> <p>(2) Providing guidance on and monitoring implementation of QA at programme and course levels;</p> <p>(3) Practising self-reflection and compiling various annual reports;</p> <p>(4) Collecting and reviewing students' and other stakeholders' comments (e.g., via Staff-Student Consultative Meetings, Advisory Committee) from time to time for continuous improvement;</p> <p>(5) Following up on improvement plans in previous Reports;</p> <p>(6) Following up on recommendations made by the Academic Consultation Panel and Departmental Academic Advisor;</p> <p>(7) Seeking views from Department Advisory Committee for continuous improvement;</p> <p>(8) Formulating improvement plans with measurable targets and concrete time frame for continuous enhancement.</p>
<p><b>Programme</b> Note 3</p>	<p>Programme Planning Team and Programme Management Committee are involved in developing and overseeing programmes.</p> <p><u>Programme Planning Team</u> is responsible for:</p> <p>(1) Preparing planning proposals of programmes with reference to strategic positioning, curriculum and pedagogical design and assessment strategies of the programme.</p> <p><u>Programme Management Committee</u> is responsible for:</p> <p>(1) Monitoring teaching and learning activities of respective programmes;</p> <p>(2) Collecting and reviewing students' and other stakeholders' comments on the programme from time to time;</p> <p>(3) Formulating improvement plans with measurable targets and concrete time frame for continuous enhancement.</p>

Note 1 "Faculty/Faculties" is a generic and collective term referring to Faculties and Schools of HKBU.

Note 2 Divisions of BNU-HKBU United International College are equivalent to Faculties; Programmes are equivalent to Departments in HKBU.

Note 3 For programmes jointly offered by multiple departments, Programme Planning Teams and Programme Management Committees will consist of representatives from every department involved in the programmes.
